Bidders, submitting their bid electronically, may also deposit the cost of bidding document in the MulSanchit Kos (account) as specified above and the scanned copy (pdf format) of the bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

- If last date of purchasing and/or submission falls on a government holiday, then next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same prescribed for the original last date of bid submission. The bid validity and bid security shall be counted after date of bid opening.
- Bidders are advised to visit site and assess the actual site conditions before submitting their bid.
- Bardaghat Municipality reserves the right to accept or reject, wholly or partly any or all the bids without assigning any reason, whatsoever.
- The place of bid purchase, bid submission and bid opening will be in Bardaghat Municipality, Office of the Municipal Executive.
