4. Pre-bid meeting shall be held at **Bardaghat Municipality, Bardaghat, Nawalparasi** at **2:00 PM on 2074/1/10**
5. Sealed bids must be submitted to the office **Bardaghat Municipality, Nawalparasi** on or before **12:00 Noon** on **2074/1/21**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2:00 pm** on **2074/1/21** at the Bardaghat Municipality, *Nawalparasi*. Bids must be valid for a period of **90 (Ninety) days** after bid opening and must be accompanied by a bid security, amounting to a minimum of **NRs. 1,20,000.00** which shall be valid for 30 days beyond the validity period of the bid.
